The City of Riverside Fire Department is not liable for any work done or not done by any of the fire protection companies on this list. You should conduct your own investigation into the qualifications, including references, of each fire protection company prior to hiring any of them to do any work. You should investigate and make sure the company is currently licensed, bonded, and insured.

California State Fire Marshal (CSFM) Fire Extinguisher License Types

Type A - Services any or all types of fire extinguishers

Type B - Maintenance and recharging of water based fire extinguishers and external maintenance of carbon dioxide fire extinguishers

Type C - Hydrostatic tests of low pressure fire extinguisher cylinders.

Type D - Perform maintenance and recharging of dry chemical, dry powder and external maintenance of halogenated agent fire extinguishers

Type E - Hydrostatic tests of high pressure fire extinguisher cylinders

Type F - Internal maintenance, recharge and recover halogenated agents from portable fire extinguishers

Type L - Limited to public or private entities that are not engaged in the business of servicing fire extinguishers
